A P P L I C A T I O N

Comes now Cities Service Oil & Gas Corporation and applies to the Oil Conservation Division of New Mexico for an order pooling all mineral interests in the West Bravo Dome Carbon Dioxide area, underlying Section 30, Township 18 North, Range 29 East, NMPM, Harding County, New Mexico, for the formation of a proration and spacing unit for the said production, and in support thereof would show the Commission:

1. Applicant is an owner of the right to drill and develop Carbon Dioxide in Section 30, Township 18 North, Range 29 East, NMPM.

2. Applicant proposes to drill a carbon dioxide well at a standard location 1650 feet from the North and East lines of Section 30 and to dedicate all of said Section to the well.

3. Applicant has sought to obtain the cooperation of all parties.

4. In order to obtain their just and equitable share of the production underlying the above lands, Applicant needs an order pooling the mineral interests involved.

5. Those who have not consented to join in the drilling of the well, with their addresses, to the best of applicant's information and belief, are as follows:

6. The parties named in paragraph 5 above have been furnished a copy of this application.

WHEREFORE, applicant prays that this application be set for hearing before the Division's duly appointed examiner, and that after notice and hearing as required by law, the Division enter its order pooling the mineral interest described herein. Applicant further prays that it be named operator of the well, and that the order make provision for applicant to recover out of production its costs of drilling the subject well, completing and equipping it, costs of operation, including costs of

supervision and a risk factor in the amount of 200% for the drilling of the well, and for such other and further relief as may be proper.
