

CASE 8670: In the matter of the hearing called by the Oil Conservation Division on its own motion to consider an order creating, contracting vertical and horizontal limits, redesignating, and extending certain pools in Chaves, Lea, and Roosevelt Counties, New Mexico:

(a) CREATE a new pool in Lea County, New Mexico, classified as an oil pool for Mississippian production and designated as the Northeast Eidson-Mississippian Pool. The discovery well is the Mesa Petroleum Co. Townsend State Com Well No. 1 located in Unit J of Section 3, Township 16 South, Range 35 East, NMPM. Said pool would comprise:
