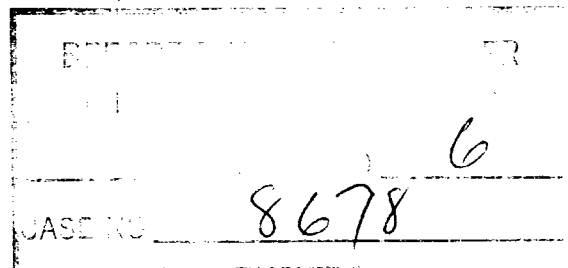

A P P L I C A T I O N

Comes now ROBERT M. EDSSEL, INC., and applies to the Oil Conservation Division of New Mexico for an order pooling all mineral interests in the Wolfcamp Formation for a spacing and proration unit consisting of the SE/4NW/4 and NE/4SW/4 Section 1, Township 15 South, Range 36 East, NMPM, Lea County, New Mexico.

1. Applicant is the owner of the right to drill and develop the SE/4NW/4 and NE/4SW/4 of Section 1, Township 15 South, Range 36 East, NMPM.

2. Applicant has drilled a Wolfcamp test in said Section 1.

3. Applicant has sought the cooperation of all parties involved in the drilling of the well.

4. In the event voluntary efforts are unsuccessful, it is necessary for the applicant to have a forced pooling case heard by the Division on March 14, 1984.

5. The party who has not yet consented to the pooling of his royalty interest as proposed is as follows:

6. In order to obtain their just and equitable share of the production underlying the above lands, Applicant needs an order pooling the mineral interest involved.

7. The party names in paragraph 5 above has been furnished a copy of this application.

WHEREFORE, applicant prays that this application be set for hearing before the Division's duly appointed examiner, and that after notice and hearing as required by law, the Division enter its order pooling the mineral interest described herein. Applicant further prays that it be named operator of the well, and that the order make provisions for applicant to recover out of production its costs of drilling the subject well, completing and equipping it, costs of operation, including costs of supervision and a risk factor in the amount of 200% for the drilling of the well, for such other and further relief as may be proper.
