and applies to the Oil Conservation Division of New
Mexico for an Order pooling all mineral interests
from the surface to the base of the Granite Wash
formation, underlying the NE/4 of the SW/4 of Section
7, Township 22 South, Range 38 East, Lea County, New
Mexico, for the formation of a proration and spacing
unit for the said production, and in support thereof
would show the Commission:

1. Applicant is an owner of the right to drill
and develop the NE/4 of the SW/4 of Section 7,
Township 22 South, Range 38 East, NMPM.

2. Applicant proposes to drill a well at a
standard location and to dedicate the NE/4 of the
SW/4 of said Section to said well.

3. Applicant has sought to obtain the cooperation of all parties.

4. In order to obtain their just and equitable share of the production underlying the above lands, Applicant needs an Order pooling the mineral interest involved.

The foregoing working interest totals 50%.


6. The party named in paragraph 5 above has been furnished with a copy of this application by certified mail.
