ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8 a.m. on September 25, 1985, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this _____ day of ______, 1985, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Benson-Montin-Greer Drilling Corp., seeks approval of an unorthodox oil well location 900 feet from the South line and 1650 feet from the West line of Section 31, Township 26 North, Range 1 West, NMPM, Rio Arriba County, New Mexico.
- (3) That said unorthodox oil well location, to be drilled and completed in the West Puerto Chiquito Mancos Oil Pool, is necessary to offset the Dugan Petroleum Company Tapacitos No. 4 well to be located 1100 feet from the South line and 1600 feet from the East line of Section 36, Township 26 North, Range 2 West, NMPM, Rio Arriba County, New Mexico and which is to be completed in the Mancos formation.

- (4) That all of said Section 31 is to be dedicated to the well.
- (5) That a well at said unorthodox location will better enable applicant to protect its correlative rights.
- (6) That no offset operator objected to the proposed unorthodox location.
- (7) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the oil in the affected pool, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:

- (1) That the application of Benson-Montin-Greer Drilling Corp. for an unorthodox oil well location in the Mancos Formation is hereby approved for a well to be located at a point 1650 feet from the West line and 900 feet from the South line of Section 31, Township 26 North, Ranged 1 West, NMPM, West Puerto Chiquito Mancos Oil Pool, Rio Arriba County, New Mexico.
- (2) That all of said Section 31 South shall be dedicated to the above-described well.
- (3) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
