Dear Mr. Russell:

I firs contacted Mr. Ralph Way concerning the captioned land on Monday, July 18, 1983, and offered \$75/acre for a five (5) year, 3/16 lease with no restrictions. I tried to reach Mr. Way twice on Wednesday, July 20, 1983 without success. I called him again on Friday, July 22, 1983, and he told me that you would probably want a 1/4 royalty, but he had not talked to you or Mr. Mills. Shortly thereafter, on Friday, July 22nd, I called you and we discussed various terms for an oil and gas lease. Chama Petroleum was willing to pay \$75/acre for a 3 year, 3/16 lease which you said was unacceptable. You then told me that yourself, Mr. Way and Mr. Mills would require \$100/acre bonus for a two (2) year lease with a 3/16 royalty and a depth limit of -3,000 ft.

I considered these to be unreasonable terms and in the following days I considered reasonable alternatives. On August 2, 1983, I called you and said that we would be willing to pay \$100/acre for a 2 year, 3/16 royalty lease if we could have the rights from the surface to 100' below total depth drilled.

You rejected this offer on behalf of yourself, Mr. Mills and Mr. Way, whereupon I made the offer of a 1/4 royalty lease with an 18 month term and no bonus, which is the type of agreement we have made with other industry people in the area. You rejected this offer and told me the lease would cost \$100/acre for a 2 year lease with a 3/16 royalty above 3,000', and a 1/4 royalty below 3,000'.

We feel that there are three options that are economical for this prospect.

- 1. A two year lease with a 3/16 royalty, paying \$100/acre bonus and earning the rights to 100' below total depth drilled.
- 2. A 1/4 royalty lease for 18 months, no bonus, earning the rights to 100' below depth drilled.
- 3. Participate in this prospect with your interests.

Please reply in writing on behalf of yourself, Mr. Mills and Mr. Way at your earliest convenience.
