## APPLICATION

Comes now, READING & BATES PETROLEUM CORPORATION, by and through its undersigned attorneys and, as provided by Section 70-2-17, N.M.S.A. (1978), hereby makes application for an order pooling all of the mineral interests in the Mancos-Dakota formations in and under the E/2 of Section 15, Township 25 North, Range 2 West, N.M.P.M., Rio Arriba County, New Mexico, and in support thereof would show the Division:
