APPLICATION FOR A HEARING

COMES NOW, Petro-Thermo Corporation, by and through its attorneys, Maddox, Renfrow & Saunders, and applies, pursuant to Rule 1203, for a hearing before the Oil Conservation Commission, to consider Petro-Thermo Corporation's Request for an Exception to Order No. R-3221 dated May 1, 1967. The following information is provided in support of this application:

 Petro-Thermo Corporation is a common motor carrier operating under a certificate of public convenience and necessity issued by the State Corporation Commission on July 8, 1981 with endorsements dated August 27, 1981 and February 10, 1982.
 A copy of the Certificate and endorsements are attached hereto as Exhibit "A" and are incorporated herein by reference.
 Petro-Thermo Corporation possesses authority to transport various solids and liquids between points in Lea, Chaves, Curry, DeBaca, Eddy, Guadalupe, Harding, Lincoln, Morrow, San Miguel, Quay and Union Counties, New Mexico. Petro-Thermo Corporation is the holder of a Form C-133 (Authorization to Move Produced Water) approved by the Oil Conservation Commission.

2. Petro-Thermo Corporation desires to obtain an Exception to Oil Conservation Commission Order No. R-3221 which would permit it to dispose of solids and water, obtained in conjunction with the production of oil or gas, on the surface of the ground on tracts of land being the NE 1/4, NE 1/4 and SE 1/4, NE 1/4 of Section 16, Township 20 South, Range 32 East, N.M.P.M., Lea County, New Mexico. Plats of the proposed disposal sites are attached hereto as Exhibit "B" and are incorporated herein by | reference.

3. Upon information and belief, Petro-Thermo Corporation states that potentially usable ground water will not be affected by the proposed disposal of solids and production water on the above-described tracts of land. Further, disposal would not constitute a hazard to existing fresh water supplies as designated by the State Engineer in the vicinity. Exceptions have been previously granted for proposed surface disposal sites located near the above described tracts of land in the vicinity of Laguna Plata.

WHEREFORE, Petro-Thermo Corporation prays for a hearing to consider its request for an Exception to Order No. R-3221.

ENDORSEMENT

Transportation of oilfield equipment and supplies (as defined in Order issued by the State Corporation Commission the 17th day of September 1947), between points and places in Lea and Eddy Counties, New Mexico, over irregular routes, under nonscheduled service.

Transportation of houses, between points and places in Lea and Eddy Counties, New Mexico, over irregular routes, under nonscheduled service.

Transportation of water and crude oil to and from wildcat wells to common carrier loading points and refineries, and residue oil from tank batteries, in Chaves, Lea, Eddy, Curry and Roosevelt Counties in New Mexico; over irregular routes and under non-scheduled service.
