This letter is to advise you that Nearburg Producing Company has filed an application with the New Mexico Oil Conservation Division seeking authority to drill a well at an unorthodox location at a point 2460 feet from the South line, and 660 feet from the East line of Section 12, Township 17 South, Range 37 East, N.M.P.M., Lea County, New Mexico. Nearburg Producing Company plans to complete this well in the Strawn formation.

This application has been set for hearing before a Division Examiner on January 22, 1986. You are not required to attend this hearing, but as an offsetting interest owner you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.
