ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on July 23 and August 6, 1986, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this <u>6th</u> day of August, 1986, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) There is need for the contraction of the Otero-Gallup Oil Pool in Rio Arriba County, New Mexico, in order to place the deleted acreage in the West Lindrith Gallup-Dakota Oil Pool.

(3) There is need for certain extensions to the Angels Peak-Gallup Associated Pool, the Bisti-Lower Gallup Oil Pool, the South Bisti-Gallup Oil Pool, the Blanco-Fruitland Pool, and the WAW Fruitland-Pictured Cliffs Pool, all in San Juan County, New Mexico, and the Blanco-Mesaverde Pool and the Otero-Chacra Pool, both in Rio Arriba and San Juan Counties, New Mexico, and the South Blanco-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico, and the Counselors Gallup-Dakota Oil Pool, the South Lindrith Gallup-Dakota Oil Pool, the West Lindrith Gallup-Dakota Oil Pool, and the Lybrook-Gallup Oil Pool, all in Rio Arriba and Sandoval Counties, New Mexico, and the Rusty-Chacra Pool in Sandoval County, New Mexico. -2-Case No. 8953 Order No. R-8273



IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within the said 60-day period shall subject the well to carcellation of allowable.

(2) The effective date of this order and all contractions and extensions included herein shall be August 1, 1986. -6--Case No. 8953 Order No. R-8273
