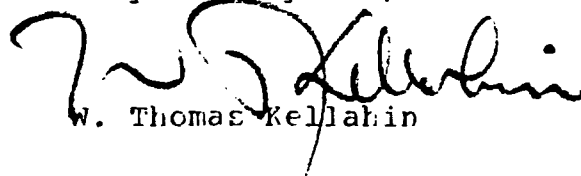
Dear Mr. Stamets:
