After reviewing Mr. Kellahin's letter of December 22, 1986 and after consultation with my client's (Barbara Fasken) engineering staff we object to the Pennzoil request as proposed by Mr. Kellahin's letter.

Pennzoil's application in case 9003 was hotly contested and took nearly an entire day to hear. No mention of a typographical condition was ever mentioned during the hearing. Such a condition - as an academic and practical matter - should have been ascertained prior to hearing.

To allow the well to be drilled at another location now without benefit of hearing would be improper. A new case should be advertized and should proceed to hearing as requested on January 21, 1987.

We further object to the proposed advertizement of the case on the basis of the evidentiary conditions placed on application. All parties affected should have an
