This cause came on for hearing at 8:15 a.m. on April 8, 1987, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 15th day of April, 1987, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

#### FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) There is need for the dismissal of the proposed creation of the Cedar Lake-Strawn Pool in Section 4, Town-ship 18 South, Range 30 East, NMPM, Eddy County, New Mexico, pending further study.
- (3) There is need for the dismissal of the proposed creation of the Esperanza-Wolfcamp Pool in Section 12, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico, pending further study.

Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.
