
Dear Mr. LeMay:

On August 4, 1987 we hand delivered an application for compulsory pooling for Meridian Oil Inc. requesting the pooling of the NE/4NE/4 of Section 35, T18S, R35E, NMPM, Lea County, New Mexico.

That application contained two errors which we request you correct on your copies of our application: (1) Paragraph 8 states that Meridian Oil Inc. is to receive its farmout from Union Texas Petroleum Company. The farmout is in fact from Union Oil Company of California; and (2) the well is to be drilled to the base of the Strawn formation and not the Devonian.

It is our understanding that neither error will require re-advertisement of the application and that the hearing will still be held on August 26, 1987.

A P P L I C A T I O N

Comes now MERIDIAN OIL INC., by and through its attorneys, Kellahin, Kellahin & Aubrey, and applies to the New Mexico Oil Conservation Division for an order pooling all mineral interests from the surface to the base of the Devonian Formation underlying the NE/4NE/4 of Section 35, Township 18 South, Range 35 East, NMPM, Lea County, New Mexico, for the formation of a proration and spacing unit for the said production, and in support thereof would show the Division.

1. Applicant is the owner of the right to drill and develop the NE/4NE/4 of Section 35, Township 18 South, Range 35 East.

2. Applicant proposes to drill a well to test the Devonian formation by drilling a well at a standard location to a total depth of approximately 10,800 feet.

3. Applicant has sought to obtain the cooperation of all parties.

4. In order to obtain their just and equitable share of the production underlying the above lands, Applicant needs an order pooling the mineral interest involved.

5. Those who have not consented to join in the drilling of the well, with their address, to the best of the applicant's information and belief, are as follows:

6. Applicant has contacted Conoco Inc. and is in the process of obtaining a farmout from Conoco, but has not yet completed this voluntary agreement.

7. Applicant has also contacted both Hondo and Arco and is of the opinion that the interest now held by Arco will be assigned to Hondo Oil & Gas but has not yet been

completed. Applicant is further of the belief that Hondo will reach a voluntary agreement with applicant but is unable to determine when that will be.

8. Applicant must commence the drilling of this well on or before September 12, 1987 in order to fulfill the terms of its farmout agreement with Union Texas Petroleum Company and despite its good faith efforts has not been able to complete voluntary agreements with all working interest owners.

9. Applicant seeks a compulsory order which will allow it to commence the drilling of the subject well in the event it is unable to obtain voluntary agreement from all working interest owners.

10. The parties named in paragraph 5 above have been furnished a copy of this application.


WHEREFORE, applicant prays that this applicant be set for hearing before the Division's duly appointed examiner, and that after notice and hearing as required by law, the Division enter its order pooling the mineral interest described herein. Applicant further prays that it be named operator of the well, and that the order make provisions for applicant to recover out of production its costs of drilling the subject well, completing and

equipping it, costs of operation, including costs of supervision and a risk factor in the amount of 200% for the drilling of the well, for such other and further relief as may be proper.
