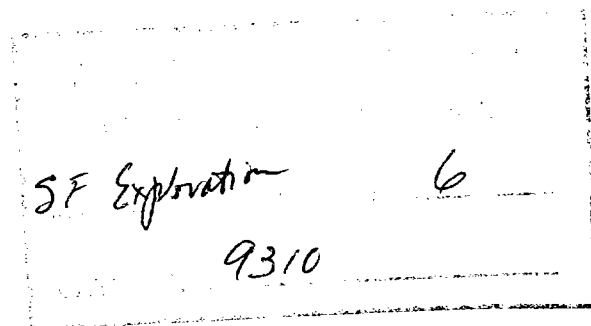

Sun Exploration and Production Company provides an incremental cost breakdown for each potential productive formation likely to be encountered enroute to the Morrow formation.
