5                   DIRECT EXAMINATION

6 BY MR. ROYBAL:

7                   Q           Will you please state your name, by whom  
8 you're employed, and in what capacity?

9                   A           I'm Michael E. Stogner, petroleum  
10 engineer here in Santa Fe with the New Mexico Oil  
11 Conservation Division.

12                  Q           Mr. Stogner, have you prepared any  
13 exhibits in this matter?

14                  A           Yes, yes, I have. I've got a package of  
15 exhibits with four exhibits.

16                  Q           Will you please describe those exhibits  
17 for the hearing examiner?

18                  A           I'll refer first to Exhibit Number Three,  
19 which is the -- a copy of the statutes which describes the  
20 name change from the Energy and Minerals Department to the  
21 Energy, Minerals and Natural Resources Department, and this  
22 hearing is -- today is to change two forms, those being the  
23 Application for Wellhead Price Ceiling Category Determina-  
24 tions and Application for Continued Stripper Classifications  
25 under the NGPA. I'll refer to Exhibits Number One and Two,

1 being those two forms, to reflect the name change of the De-  
2 partment on these. The name change occurred during the 38th  
3 State Legislature of New Mexico in its first session under  
4 -- enacted under Chapter 234, known as the Energy, Minerals  
5 and Natural Resources Department Act, and made effective  
6 July 1st, 1987, and that's all that I proposed today on  
7 these two forms.

8 Q Mr. Stogner, then the changes in Exhibits  
9 One and Two are made necessary by the statutory change found  
10 in Exhibit Three, is that correct?

11 A That is correct.

12 MR. ROYBAL: Mr. Hearing Exam-  
13 iner, I move the admission of Exhibits One, Two and Three in  
14 this matter. And Four.

15 A Exhibit Number Four is a proposed rough  
16 draft copy of the order I prepared for the hearing officer.

17 Q Thank you, Mr. Stogner.

18 MR. CATANACH: Thank you. Ex-  
19 hibits One through Four will be admitted into evidence at  
20 this time.
