ORDER OF THE DIVISION

BY THE DIVISION

This cause came on for hearing at 8:15 a.m. on May 11, 1988, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this _____ day of May, 1988, the Division Director, having considered the testimony, the record and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) By its Order No. R-5878-B, effective July 15, 1980, the New Mexico Oil Conservation Division promulgated "Special Rules for Application of Wellhead Price Ceiling Category Determinations" pursuant to the Natural Gas Policy Act of 1978 and the "Final Regulations Implementing Filing Requirements of the Natural Gas Policy Act of 1978," as promulgated by Federal Energy Regulatory Commission (FERC) Order No. 65 effective February 4, 1980.

(3) Said special rules and the Division forms adopted pursuant thereto have from time to time been amended to conform with the FERC regulations as they have been amended, to eliminate unnecessary paperwork, to include various provisions necessary to up-grade filing procedures and to include a provision for filing fees.

(4) The 38th State Legislature of New Mexico, at its first Session, enacted Chapter 234, Laws of 1987, approved April 9, 1987, being the "Energy, Minerals and Natural Resources Department Act," and made effective July 1, 1987.

(5) Said act established a single, unified Department to administer laws and exercise functions formerly administered and exercised by the Natural Resources Department and the Energy and Minerals Department, known as the Energy, Minerals and Natural Resources Department, among the Division of which the Oil Conservation Division is included.

(6) Division Form C-132, "Application for Wellhead Price Ceiling Category Determination," and Division Form C-132-A, "Application for Continued Stripper Classification," should be revised to reflect the Department name change as shown on Exhibits A and B respectively, attached hereto and made a part hereof.

(7) All other provisions included in said Order No. R-5878-B, as amended, should remain in full force and effect.

(8) This order should be made effective May 16, 1988.

IT IS THEREFORE ORDERED THAT

(1) The New Mexico Oil Conservation Division Form C-132, "Application for Wellhead Price Ceiling Category Determination," is hereby revised to conform to Exhibit A attached hereto and, by reference, made a part hereof.

(2) Division Form C-132-A, "Application for Continued Stripper Classification," is hereby revised to conform to Exhibit B attached hereto and, by reference, made a part hereof.

(3) The effective date of this order shall be May 16, 1988.

(4) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.


