APPLICATION

Standard Oil Production Company, by and through its undersigned attorneys, hereby makes application to the Oil Conservation Division for approval of an unorthodox gas well location, and in support thereof states:

1. Applicant is the operator of the N/2 NE/4 of Section 36, Township 16 South, Range 37 East, N.M.P.M., Lea County, New Mexico, and proposes to drill a well from a surface location 1060' FEL and 1300' FNL of said Section 36 to within 150 feet of a bottom hole location 1180' FEL and 1090' FNL of the same section.

2. Applicant seeks an exception to the well location requirements of Oil Conservation Division Rule 104 to permit the drilling of the well at the above described unorthodox location to a depth sufficient to adequately test the Strawn Formation.

3. A standard 80 acre proration unit comprising the N/2 NE/4 of said Section 36 should be dedicated to the well.

4. That approval of this application will afford applicant the opportunity to produce its just and equitable share of hydrocarbons underlying this spacing unit and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Applicant prays that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division on May 25, 1988, and that after notice and hearing as required by law, the Division enter its order granting this application and providing such other relief as is proper.
