Dear Wayne:

Reference is made to our numerous phone conversations and your letters dated June 1, 1988. Amerada Hess Corporation (AHC) firmly believes, based on its geophysical data that the best location to drill the initial Strawn Test Well is in the SE/4 of Section 33, 16S-38E, and that an Area of Mutual Interest would be in the best interest of our two companies. However, since Anadarko chooses not to consider this proposal we see no reason to meet and share data. In the spirit of cooperation and to support your test well, AHC hereby offers to farmout to Anadarko its interest in the E/2SE/4 of Section 28, 16S-38E, subject to the following terms:

- (1) Within ninety (90) days of the date of a formal farmout agreement you will commence actual drilling operations of a Strawn test well located at a legal location in the E/2SE/4 of Section 28, 16S-38E. Said well will be drilled to a depth of 12,000 feet or to a depth sufficient to test the Strawn formation, whichever is the lesser depth.
- (2) Completion of the Test Well as a commercial producer will earn Anadarko all of AHC's interest in the proration unit established for the test well, from the surface of the earth down to 100' below the total depth drilled.
- (3) AHC will reserve a twenty-five percent (25%) overriding royalty less lease burdens with the option to convert said override to a twenty-five percent (25%) working interest at payout of the Test Well. Said override and working interest will be proportionately reduced to the original interest assigned to Anadarko.
- (4) AHC will have a call on its share of production from the initial test well.

I will immediately prepare a formal farmout agreement and forward to your attention.
