## APPLICATION

Inexco Oil Company, a wholly owned subsidiary of The Louisiana Land and Exploration Company, applies for an order approving an unorthodox oil well location, and in support thereof states:

- 1. Applicant has the right to drill a well in the NW&NW&Of Section 17, Township 16 South, Range 36 East, N.M.P.M., Lea County, New Mexico.
- 2. Applicant proposes to drill a well at a location 1200 feet from the North line and 500 feet from the West line of Section 17, to a depth sufficient to test the Strawn formation.
- 3. The proposed well is within one mile of the West Lovington-Pennsylvanian Pool, and the NW\u00e4NW\u00e4 of Section 17 shall be dedicated to the well.
- 4. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.
- 5. Applicant requests that this matter be heard at the June 22, 1988 Examiner hearing.
