Gentlemen:

Pursuant to SLO Rule 1.052, enclosed is a copy of the Application of Yates Petroleum Corporation for Compulsory Pooling, Eddy County, New Mexico. Hearing is scheduled before the New Mexico Oil Conservation Division, in Santa Fe, New Mexico, on July 12, 1989.

The enclosed application seeks to pool N/2 Section 2, Township 20 South, Range 24 East, N.M.P.M., embraced by State Leases K-6385 covering Lots 1, 2, 3, SW/4 NE/4, S/2 NW/4 Section 2, and E-2781 covering Lot 4, SE/4 NE/4 Section 2. The record owner of K-6385 is Yates Petroleum Corporation, and the record owner of E-2781 is Kathleen Cone. Clifford Cone, Tom R. Cone, Douglas L. Cone, Kenneth G. Cone and Cathie Cone Auvenshine own interests in the operating rights in E-2781.

Also enclosed is a copy of Oil Conservation Division Form C-101, Application for Permit to Drill, approved May 8, 1989. Yates Petroleum Corporation proposes to drill its well at a location 660 feet from the north line and 1,980 feet from the west line (Unit C) of said Section 2 to a depth sufficient to test all formations from the surface through the base of the Morrow formation, at approximately 9,600 feet.

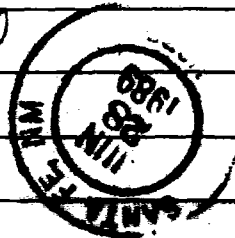
