

At the May 16, 1991 hearing in the above-referenced case certain questions were raised concerning precedence for 160-acre oil spacing rules with a 330 foot setback from the outer boundary of the spacing unit. I have discovered two cases in which similar rules have been adopted by the Division and, although not mentioned at the time of the hearing, they are official orders of the Division of which you can take judicial notice. They are the Special Pool Rules for the Media-Entrada Oil Pool as promulgated by Division Order No. R-4277 and for the Dufuce Point Gallup-Dakota Pool as promulgated by Division Order No. R-7435.

I enclose copies of each of these orders for your easy reference.
