
Hal J. Rasmussen Operating, Inc. has applied to the Oil

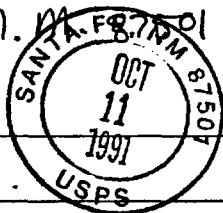
