PLEASE TAKE NOTICE that the Superintendent of Insurance ("Superintendent"), acting in his capacity as secretary of the State Insurance Board and pursuant to NMSA 1978, Sections 59A-2-9, 59A-3-6, 59A-4-15, 59A-4-16, 59A-4-18, 59A-17-5, 59A-17-8 and 59A-33-10 (1988 repl. Pam.), will conduct an infor-

mal public hearing on October 24, 1991, to receive written and oral comments, testimony and evidence of interested persons concerning a proposed regulation relating to the Basis of Premium for Workers' Compensation Insurance.

The hearing will be held at 9:30 a.m. on October 24, 1991 at the PERA Building, Fourth Floor Hearing Room, 500 Old Santa Fe Trail and Paseo de Peralta, Santa Fe, New Mexico. The Superintendent has delegated his authority to the Deputy Superintendent of Insurance, Thomas R. Rushton, to preside as the hearing officer at this hearing.

The regulation proposed by the Staff of the New Mexico Department of Insurance ("Staff") purports to establish criteria of a Premium Base; the Premium Base shall reflect the exposure to the insured against hazard and insurance coverage to be marketed at a fair price. Staff's proposed regulation shall define and alter a workable and uniform application of the system.

The proposed regulations in this docket may be inspected and copied during regular business hours at the office of the Chief Clerk for the State Corporation Commission at the address noted below.

Comments and alternative proposals will be received in both written and oral form. CASE 10398:

In the matter of the hearing called by the Oil Conservation Division on its own motion to amend Rules 403 and 1110 of the General Rules and Regulations of the New Mexico Oil Conservation Division by adopting alternate methods for measuring and reporting gas production from low capacity wells.

## RULE 403. - NATURAL GAS FROM GAS WELLS TO BE MEASURED

A. All natural gas produced shall be accounted for by metering or other method approved by the Division and reported to the Division by the transporter of the gas. Gas produced from a gas well and delivered to a gas transportation facility shall be reported by the owner or operator of the gas transportation facility. Gas produced from a gas well and required to be reported under this rule, which is not delivered to and reported by a gas transportation facility shall be reported by the operator of the well.

B. An operator may apply to the OCD District Supervisor, using form C-110, for approval of one of the following procedures for measuring gas:

(1) In the event a well is not capable of producing more than 15 MCFD, a measurement method agreed upon by the operator and pipeline whereby the parties establish by annual test the producing rate of said well under normal operating conditions and apply that rate to the period of time the well is in a producing status. In the event such well is capable of producing greater than 5 MCFD, a device shall be attached to the line which will determine the actual time period that the well is flowing.

(2) Any well which has a producing capacity of 100 MCFD or less and which is on a multi-well lease may be produced without being separately metered when the gas is measured using a lease meter at a Central Point Delivery (CPD). The ownership of the lease must be common throughout including working interest, royalty and over-

riding royalty ownership.

C. Operators and transporters shall report the well volumes on Forms C-115 and C-111 based upon the approved method of measurement and, in the case of a CPD, upon the method of allocation of production to individual wells approved by the District Supervisor.

## RULE 1110 - APPLICATION FOR APPROVAL TO USE AN ALTERNATE GAS MEASUREMENT METHOD (FORM C-110)

A. Form C-110 shall be used in authorizing an alternate procedure for measuring gas production from a well which is not capable of producing more than 15 MCFD (Rule 403.B.(1)) or for any well which has a producing capacity of 100 MCFD or has and is on a multi-well lease (Rule 403.B.(2)).

B. All applicable information required on Form C-110 shall be filled out with the required supplemental information attached, and shall be submitted in QUADRUPPLICATE to the appropriate district office of the Division.

### NOTICE OF PUBLIC HEARING TO CONSIDER PROPOSED AMENDMENTS TO THE STATE IMPLEMENTATION PLAN'S AIR QUALITY PROVISIONS FOR ANTHONY, NEW MEXICO

The New Mexico Environmental Improvement

Board will hold a public hearing on November 8, 1991, beginning at 1:00 p.m., in the Harold Runnels Building Auditorium, 1190 St. Francis Drive, Santa Fe, New Mexico, to consider proposed amendments to the State Implementation Plan (SIP) for Air Quality.

The proponent of the amendment is the New Mexico Environment Department. The proposal consists of revisions to the PM<sub>10</sub> (particulate matter less than or equal to 10 microns in diameter) SIP for Anthony, New Mexico. The proposed amendment is required in order for the State to meet requirements contained in the federal Clean Air Act.

The proposed amendment may be reviewed during regular business hours at the office of the Environmental Improvement Board, Harold Runnels Building, 1190 St. Francis Drive, Room S-4100, Santa Fe, NM or copies may be obtained by contacting Ms. Lany Weaver, Air Quality Bureau Environmental Engineer, 1190 St. Francis Drive, Room S-2100, Santa Fe, NM, telephone number 827-2859.

All interested persons will be given a reasonable opportunity at the hearing to submit relevant evidence, data, views, and arguments, orally or in writing, to introduce exhibits and to examine witnesses in accordance with the Environmental Improvement Act, Section 74-1-9 NMSA 1978, the Air Quality Act, section 74-2-6 NMSA 1978 and the Board's Guidelines Governing hearings.

Persons desiring to present technical testimony shall submit to the Board a written statement of intent to do so. Persons paraphrasing, summarizing or reading from a prepared statement must submit the written testimony together with the statement of intent and shall be received by the Office of the Board not later than 5:00 p.m. October 29, 1991. Notices of intent must include:

1. name and qualification of each technical witness;
2. the name of the person proffering the witness;
3. whether the person proffering the witness is a proponent, opponent, or interested party;
4. description of the nature, subject and anticipated length of the testimony;
5. identify the specific aspects and proposed action along with alternative language proposal where appropriate;
6. a list and description of technical exhibits to be offered in connection with the
