





This order approved the unorthodox location of its Smith Federal Gas Com No. 2 Well at a point 2049 feet from the North line and 480 feet from the West line of Section 12, Township 22 South, Range 23 East, N.M.P.M., Eddy County, New Mexico and assigned an acreage factor of 0.49 to this well for allowable purposes in the Indian Basin-Upper Pennsylvanian Pool. Applicant seeks amendment of this order to increase the acreage factor assigned to the well.




