

1. I am an attorney practicing in the law firm of Tansey, Rosebrough, Gerding & Strother, P.C., Farmington, New Mexico.
2. At all times material to the events which are the subject of this Affidavit, I represented Snyder Oil Corporation.
3. On or about January 26, 1994, I caused to be filed with the New Mexico Oil Conservation Division, on behalf of Snyder Oil Corporation, an application seeking the approval of the downhole commingling of production from the Wildcat Gallup Oil Pool and the Basin Dakota Gas Pool in the wellbore of the Snyder Oil Corporation Con Hale #2E Well located in the SW/4SW/4 (Unit M) of Section 15, Township 26 North, Range 8 West, N.M.P.M., San Juan County, New Mexico.
4. The application of Snyder Oil Corporation for downhole commingling was assigned Case No. 10908 and was set to be heard at the Examiner Hearing scheduled for February 17, 1994.
5. On January 26, 1994, I caused to be placed in the United States Mail a letter to each of the individuals and entities identified in Exhibit "A", attached hereto and incorporated herein by reference for all purposes, at their respective addresses as set forth in Exhibit "A", which letter notified each individual and entity that Snyder Oil Corporation had filed an application with the New Mexico Oil Conservation Division for downhole commingling, that the application had been set to be heard at the Examiner Hearing scheduled for February 17, 1994, and that each individual and entity had the right to appear at the hearing to present testimony and submit evidence in support of his or its position regarding the merits of the application.
6. Each of the individuals and entities identified in Exhibit "A", except the Bureau of Land Management, have been identified as operators of lands and/or wells offsetting the Con Hale #2E Well and as such they are entitled to receive notice of the application of Snyder Oil Corporation in accordance with the rules and regulations of the New Mexico Oil Conservation Division pertaining to notice.

7. The Bureau of Land Management is entitled to receive notice of the application of Snyder Oil Corporation in accordance with the rules and regulations of the New Mexico Oil Conservation Division pertaining to downhole commingling operations.
8. Snyder Oil Corporation has conducted a good-faith diligent effort to find the correct address of all interested parties entitled to receive notice pursuant to the rules and regulations of the New Mexico Oil Conservation Division.
9. To the best of my knowledge and belief, the address set forth in Exhibit "A" for each individual and entity is the correct address for that individual or entity and notice has been given at that correct address as provided by the rules and regulations of the New Mexico Oil Conservation Division.
10. To the best of my knowledge and belief, Snyder Oil Corporation has complied with the notice provisions set forth in Rule 1207 of the Rules and Regulations of the New Mexico Oil Conservation Division.

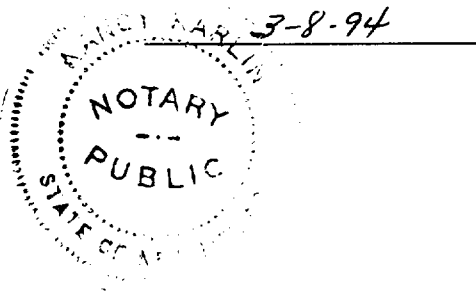
