

A P P L I C A T I O N

Comes now Apollo Energy Inc., by and through its attorneys, Kellahin & Kellahin, and applies to the New Mexico Oil Conservation Division for authority to dispose of produced salt water into the Bough "C" Formation through open hole completion from 9597 feet to 9615 feet in its Federal A-13 well #1 located in Unit C, 660 feet from the North line and 1980 feet from the West line of Section 13, T9S, R35E, NMPM, Lea County, and in support thereof would show:

1. Applicant is the operator of its Federal A-13 well #1 well located in Unit C of Section 13, T9S, R35E, Lea County, New Mexico.
2. Applicant seeks to dispose of salt water in the Bough "C" Formation open hole at 9597 feet to 9615 feet.
3. Applicant is preparing Division Form C-108 and will submit that application separate from this application.

4. Wherefore, Applicant requests that this application be set for hearing and that after notice and hearing the application be granted.
