

COMES NOW, SUN EXPLORATION AND PRODUCTION COMPANY, by and through its attorneys, KELLAHIN & KELLAHIN, and applies to the New Mexico Oil Conservation Division for approval of an Unorthodox Oil Well located 2,700 feet from North line and 1,610 feet from the East line of Section 27, Township 9 South, Range 36 East, NMPN, Crossroads Devonian Oil Pool, Lea County, New Mexico, and in support thereof would show:

1. Applicant has the right to drill and develop the SW/4 of the NE/4 of Section 27, Township 9 South, Range 36 East, Lea County, New Mexico.

2. Applicant proposes to drill its U.D. Sawyer No. 11 Well, at an Unorthodox Oil Well location 2,700 feet from the North line, 1,610 from the East line of Section 27, Township 9 South, Range 36 East, NMPN.

3. Applicant proposes to dedicate the SW/4 of the NE/4 to said well.

4. Applicant proposes to attempt a completion in the Crossroads Devonian Oil Pool.
