Phillips Oil Company requests your waiver of objection to the drilling of the Burch C Fed Well No. 45, subject to archeological clearance, 330' from the North line and 2580' from the West line, Unit C, Section 23, T-17-S, R-29-E, Eddy County, New Mexico. This proposed 3500' Grayburg Jackson Pool oil completion , which shares the proration unit with the Burch C Fed water injection Well No. 17, is less than the required 330' minimum distance from nearest guarter-quarter section line. Further, we request your waiver of objections to an alternate unorthodox location within Unit C, as may be necessary to secure archeological clearance to drill, so long as that alternate location is at least 330 feet from the north section line.

The proposed location conforms with a water injection program being developed on the Burch C Fed lease in a cooperative waterflood project involving other adjacent Phillips Oil Company leases.
