

NOMENCLATURE ADVERTISEMENT FOR NOVEMBER 1984

In the matter of the application of the Oil Conservation Division of the Energy and Minerals Department upon its own motion for an order for the creation of new pools in Chaves and Eddy Counties, New Mexico, the extension of the vertical limits and redesignation of certain existing pools in Eddy County, New Mexico, and the extension of horizontal limits of certain existing pools in Chaves and Eddy, Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such creations and extensions should not be made.

(a) CREATE a new pool in Eddy County, New Mexico, classified as a gas pool for Atoka production and designated as the North Black River-Atoka Gas Pool. The discovery well is Hamon Oil Co., State L-4325 #1 located in Unit K of Section 2, Township 24 South, Range 26 East NMPM. Said pool would comprise:

Section 2: S/2

(b) CREATE a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production and designated as the North Willow Lake-Delaware Pool. The discovery well is Ned Maddox, Enfield Federal #1 located in Unit P of Section 17, Township 24 South, Range 28 East NMPM. Said pool would comprise:

(c) CREATE a new pool in Chaves County, New Mexico, classified as an oil pool for San Andres production and designated as the Red Lake Ridge-San Andres Pool. The discovery well is Stevens Operating Corp., O'Brien R. #1 located in Unit O of Section 21, Township 8 South, Range 29 East NMPM. Said pool described as:

NEW POOLS

It is recommended that a new Gas pool be created and designated as the North Black River-Atoka Gas Pool.

Vertical limits to be the Atoka formation and the horizontal limits should be as follows: Sec. 2: S/2

Discovery well was Hamon Oil Company, State I-4325 #1 located in Unit K Section 2 Township 24S Range 26E and was completed on 8-29-84. Top of perforations is at 10556 feet.

It is recommended that a new Oil pool be created and designated as the North Willow Lake - Delaware Pool.

Vertical limits to be the Delaware formation and the horizontal limits should be as follows: Sec. 17: SE/4

Discovery well was Ned Maddox, Enfield Federal #1 located in Unit P Section 17 Township 24S Range 28E and was completed on 6-22-84. Top of perforations is at 5991 feet.

It is recommended that a new Oil pool be created and designated as the Red Lake Ridge - San Andres Pool.

Vertical limits to be the San Andres formation and the horizontal limits should be as follows: Sec. 21: S/2

Discovery well was Stevens Operating Corporation, O'Brien R #1 located in Unit O Section 21 Township 8S Range 29E and was completed on 9-14-84. Top of perforations is at 2869.5 feet.
