Does this refer back to Order No. R-3960, issued May 12th, 1970, approving this oil treatment plant?

1 copy of that and it says southeast quarter of Section 25,  
2 Township 11 South, Range 33 East.

3 MR. LOVE: It is located in the  
4 southeast quarter of the southeast quarter of Section 7,  
5 Township 11 South, Range 33 East, is its location.

6 MR. STOGNER: Do you know if it  
7 was ever moved?

8 MR. SEXTON: As far as I know  
9 it was right there. It was a mistake originally.

10 MR. LOVE: This is Mr. Jerry  
11 Sexton with the --

12 MR. SEXTON: Mike, the location  
13 is in Section 7. It's just that our records have been wrong  
14 but I -- as far as anyone can remember, it hasn't been  
15 moved.

16 MR. STOGNER: Have we renum-  
17 bered the sections?

18 Mr. Love, do you plan to call  
19 any witnesses or --

20 MR. LOVE: Not unless you have  
21 a questions, Your Honor -- Mr. Examiner.

22 MR. STOGNER: Mr. Sexton, do  
23 you have any questions?

24 MR. SEXTON: No. We expect --  
25 we are satisfied with the transfer.

1 MR. STOGNER: Okay. Mr. Love,  
2 I'm a little bit confused. Why did we have to come to hear-  
3 ing today to change ownership?

4 MR. LOVE: I'm a little con-  
5 fused as to why we did, also. I think it was just the un-  
6 certainty when this application when this application was  
7 submitted that the publication was required just because the  
8 new regulations might have been set forth and it was a  
9 management decision to cover all bases.

10 MR. TAYLOR: Mike, the new  
11 rules and regulations require that all transfers be ap-  
12 proved.

13 It must come to hearing, I  
14 guess.

15 MR. STOGNER: Okay. As far as  
16 the actual treating plant operation, wherever it is, is  
17 there any changes or -- that will be --

18 MR. LOVE: No, sir.

19 MR. STOGNER: Seeing that the  
20 location is wrong, we're going to need to readvertise this  
21 and I'll also put another paragraph in the readvertisement  
22 changing that section; however, it will not be ready to come  
23 to hearing until February 4th.

24 So with that this case will be  
25 continued till February 4th and it will be readvertised.
