





Gentlemen:

By letter dated February 7, 1975, Northwest Pipeline Corporation, Unit Operator, filed a Drilling Program covering the captioned unit for the calendar year 1975 providing for the drilling of nine Dakota wells. On September 17, 1975, Northwest Pipeline Corporation filed a Supplemental Drilling Program providing for the drilling of six Mesaverde wells.

Of those wells proposed for the Initial 1975 Drilling Program, only the San Juan 30-5 Unit well No. 39 and the San Juan 30-5 Unit well No. 47 were completed. Well No. 39 created the First Expansion of the Dakota Participating Area effective July 1, 1975, and well No. 47 created the Second Expansion effective August 1, 1975. The remaining Dakota wells proposed for 1975 were not drilled; they are wells No. 38, 48, 49, 50, 51, 52, and 53. There are no plans to drill these wells during the calendar year 1976.

All of the Mesaverde wells proposed for the Supplemental 1975 Drilling Program were timely drilled. Wells No. 43 and 44 created

the Twenty-Fourth Expansion of the Mesaverde Participating Area effective November 1, 1975, wells No. 2-R and 45 created the Twenty-Fifth Expansion effective December 1, 1975, well No. 54 created the Twenty-Sixth Expansion effective January 1, 1975 and well No. 46 created the Twenty-Seventh Expansion effective February 1, 1976.

This is to advise that the Plan of Development for calendar year 1955, dated December 31, 1954, for the subject unit has this date been accepted by the New Mexico Oil Conservation Commission as minimum compliance with the obligation of unit operator to submit a Plan of Development, pursuant to article 10 of the Unit Agreement.

This Plan of Development is therefore accepted only on the condition that on or before April 15, 1955, a supplemental Plan of Development be filed, providing for the drilling of a minimum of five development and/or exploratory wells to a depth sufficient to adequately test the Mesaverde formation, unless unitized substances in paying quantities are encountered at lesser depth. In addition, adequate provision must be made to protect the unitized lands from drainage. We feel that due to the large amount of acreage comprising this unit, such a Plan of Development is not unreasonable and should lead to the orderly development of the subject area.

This approval is being granted subject also to the condition that like approval be obtained from the United States Geological Survey and from the Commissioner of Public Lands of the State of New Mexico.

All wells were shot with nitroglycerin except the #6-19 which in addition to being shot was also sand-oil fractured. The poor condition of the #2-29 Well is due to damaged casing.

As of December 31, 1954, the Unit Participating Area consisted of the W/2 of Sections 9, 29 and E/2 of Sections 11, 22, 35, all in Township 30 North, Range 5 West. Small quantities of gas have been produced for use as rig fuel and drilling gas.

1955 DEVELOPMENT PROGRAM

SW/4 of Section 31, Township 30 North, Range 5 West, N.M.P.M.



All drilling requirements of the Unit Agreement for San Juan 30-5 Unit have been satisfied and Phillips Petroleum Company, as Unit Operator, now submits for your approval a Plan of Development for the remainder of 1954. The San Juan 30-5 Unit Area embraces all of Township 30 North, Range 5 West, N.M.P.M., Rio Arriba County, New Mexico. Of the 22,421.8 acres within the township, 21,141.8 acres are committed to the Unit.

Five Mesaverde test wells have been completed as required by the Unit Agreement and another, Well #8-19, located in the SW/4 of Section 19-30N-5W, unsuccessfully tested the Dakota formation to fulfill the deeper drilling obligation contained in the San Juan 29-5, 29-6, 30-5 and 30-6 Unit Agreements. Well #2-29, originally an obligation well, encountered mechanical difficulty and Well #7-29 was drilled and completed as a substitute obligation well. Well #5-30 was drilled in the NE/4 of Section 30 as a test of the Fruitland-Pictured Cliffs section but has not been completed due to excessive water entry.

No gas has been sold to pipe line companies, however, gas for fuel and drilling has been produced intermittently from the #1-22, #3-9 and #6-19 wells.

As Unit Operator, we have canvassed the owners of all working interests committed to the Unit and none desire wells to be drilled on their land during the remainder of the year.

All the holdings of Phillips Petroleum Company within San Juan 30-5 Unit are subject to a contract of sale conditioned upon the issuance by the Federal Power Commission of a Certificate of Public Convenience and Necessity for the construction and operation of a gas pipeline system extending from San Juan Basin to markets in the Northwest part of the United States and intervening points. An application for the certificate has been prosecuted diligently before the Commission and it is anticipated that a decision will be rendered during the summer of this year. The gas contained within Phillips' land committed to San Juan 30-5 Unit is a material portion of the reserves upon which the pipeline application is based and which are represented to the Federal Power Commission as available for the proposed pipeline upon its completion. Consequently, Phillips Petroleum Company does not desire to drill development wells for its own account or to produce existing wells pending the forthcoming action of the Federal Power Commission, and pending commencement of construction of the proposed pipeline should a Certificate of Public Convenience and Necessity be issued.


Since (1) development to date has reasonably proved the productivity of the Unit Area, and (2) there are no existing intervening Drilling Blocks which would necessitate the drilling of additional wells at this time under the provisions of the Unit Agreement, and (3) none of the working interest owners within the Unit desire drilling at this time, Phillips Petroleum Company, as Unit Operator, plans to drill during the remainder of 1954 only such wells, if any, as you may require for the protection of the Unit against drainage, or as you may otherwise require.
