On June 16, 1972, the United States District Court for the District of Colorado, in Civil Action C-2626, ordered that certain assets and properties of El Paso Natural Gas Company ("El Paso") be divested to Northwest Pipeline Corporation ("Northwest"). This order was affirmed by the United States Supreme Court on March 5, 1973. On September 21, 1973, the Federal Power Commission issued an order authorizing Northwest to acquire and operate the assets and properties to be divested and recognizing Northwest as successor to El Paso's interests in these assets. On October 19, 1973, the District Court entered its final order directing that the divestiture be completed forthwith. The properties and assets consist primarily of El Paso's Northwest Division gas system, much of which was formerly owned by Pacific Northwest Pipeline Corporation.

Among the properties to be divested are those lands in the captioned Unit which El Paso acquired from Pacific Northwest Pipeline Corporation. In conjunction with this divestment El Paso wishes to resign as Unit Operator and Northwest wishes to succeed El Paso as Unit Operator. Upon obtaining working interest owner consent Northwest will request to be approved by the Director and the Commissioner as Successor Unit Operator.

While neither El Paso nor Northwest is certain as to specifically when Northwest will be able to replace El Paso as Unit Operator, we are both hopeful that this can be accomplished within from 60 to 90 days. For

Mountain Daylight Saving Time, Northwest Pipeline Corporation does hereby accept and assume the duties and responsibilities of Unit Operator of the San Juan 32-8 Unit and agrees to serve in such capacity until its designation as Unit Operator shall be terminated in accordance with said Unit Agreement.

Pursuant to Section 11(a) of the San Juan 32-8 Unit Agreement, #14-08-001-446, approved January 13, 1953, El Paso Natural Gas Company, as Unit Operator, determined on the date set out below that one (1) additional well capable of producing unitized substances in paying quantities from the Mesaverde Formation has been completed upon acreage committed to the unit. This well is as follows:

The San Juan 32-8 Unit #13-9 (MV) Well is located 1120' from the South line and 800' from the West line of Section 9, Township 31 North, Range 8 West, San Juan County, New Mexico. This well was spudded on September 29, 1960 and completed on October 12, 1960 at a total depth of 6090'. The Point Lookout Section of the Mesaverde Formation in the intervals between 5856' - 5862', 5866' - 5872', 5884' - 5896', 5910' - 5916', 5924' - 5930', 5942' - 5948', 5968' - 5974' was perforated and treated with a sand-water fracturing process on October 11, 1960. The well was shut-in on October 12, 1960. After being shut-in for twenty-seven (27) days, the Mesaverde Formation was tested on November 8, 1960, and following a three (3) hour blow-down period gauged 3215 MCFGPD through a 3/4" choke and 4429 MCFGPD by the calculated absolute open-flow method, with an SIPC of 1106# and an SIPT of 1106#. The committed drilling block upon which this well is located is described as the W/2 of Section 9, Township 31 North, Range 8 West, containing 320.00 acres.

The foregoing drilling block is being included in the Fifteenth Expanded Participating Area of the Mesaverde Formation, effective December 1, 1960.

Attached is Schedule XVII showing the Fifteenth Expanded Participating Area for the San Juan 32-8 Unit Area. This describes the Expanded Participating Area, shows the percentage of unitized substances allocated to each unitized tract, and the exact breakdown of percentage allocated to each tract according to the various ownerships in said tract. 



Pursuant to Section 10 of San Juan 32-8 Unit Agreement, Pacific Northwest Pipeline Corporation, as Unit Operator, respectfully submits herewith for your approval the 1960 Plan of Development for the subject unit providing for the drilling of the wells set out below during the period from January 1, 1960, to December 31, 1960.

The Plan of Development for 1959 on San Juan 32-8 Unit called for the drilling of two Mesaverde wells, also there was scheduled at least one well to be drilled to the Dakota formation. Tabulated below is the status of the wells shown on this Plan of Development.


3. Drill additional wells which may be requested by working interest owners.
