

Gentlemen:

Our Greenwood Unit No. 8, which was drilled in the SW/4 SW/4, Section 7, T-19-S, R-32-E, reached total depth on October 4, 1962, tested until October 7, 1962, and was abandoned on October 9, 1962, after logs and testing indicated the well to be dry. Based on our interpretation of Section 2(e) of the Unit Agreement the ninety day automatic elimination date for all acreage not included in a participating area is January 5, 1963, or ninety days from final testing which occurred on October 7, 1962. Please advise if such does not meet with your concurrence.

Gentlemen:

Application is hereby made for your approval of a proposed expansion of the Greenwood Pre-Grayburg Unit Area, Eddy and Lea Counties, New Mexico.

The Unit Area now comprises 8,001.92 acres. The proposed expansion will increase the Unit Area to 8,885.18 acres, an increase of 883.26 acres, and is shown on the attached plat. All of the expansion area consists of Federal leases except 40 acres, or the SW/4 NE/4 Section 13, T-19-S, R-31-E, which is a part of State of New Mexico Lease E-7588. One hundred percent (100%) of the working interest owners have approved the proposed expansion of the Greenwood Pre-Grayburg Unit Area. Of the 22 parties owning an overriding royalty interest in the expanded area 20 have executed ratifications which represents 90.9% of the total number and 83.5% on an acreage basis. The Unit Operator is of the opinion that a sufficient percentage of the lands within the expanded area are committed to afford effective control of this area.

Also attached herewith are the following letters:

- (1) A blue line copy of a letter dated May 28, 1962 from the Commissioner of Public Lands to Pan American granting preliminary approval to the proposed expansion of said unit.
- (2) Duplicate original of letter dated June 6, 1962 from the Acting Director of the USGS to Pan American granting preliminary approval for the proposed expansion of said unit.
- (3) Duplicate original of Unit Operator's letter dated June 30, 1962, addressed to the Director, USGS, and Commissioner of Public Lands, State of New Mexico, requesting final approval for the expansion of the above captioned

unit.

Pan American as Unit Operator requests the Commission's approval of the previously discussed expansion of the Greenwood Pre-Grayburg Unit Area, contingent on the final approval by the Commissioner of Public Lands and the Director, USGS. The Unit Operator will advise you of these approvals when they are received.
