A P P L I C A T I O N

TO THE HONORABLE OIL CONSERVATION COMMISSION OF THE STATE OF NEW MEXICO:

COMES NOW the Applicant, Sunray Mid-Continent Oil Company, and respectfully alleges and states as follows:

1. That it is the owner and operator of leases and wells within the limits of the Bisti-Lower Gallup Oil Pool, San Juan County, New Mexico.
2. That Sunray Mid-Continent and other operators in the Bisti-Lower Gallup Oil Pool desire to form a unit for the purpose of conducting secondary recovery operations within the following described area:

TOWNSHIP 26 NORTH, RANGE 12 WEST, NMPM

Section 31: S/2 and S/2 N/2
Section 32: S/2 and S/2 N/2
Section 33: S/2 SW/4

TOWNSHIP 25 NORTH, RANGE 12 WEST, NMPM

Section 3: SW/4
Section 4: All
Section 5: All
Section 6: All
Section 7: All
Section 8: All
Section 9: All
Section 10: NW/4
Section 16: All
Section 17: N/2 and SE/4 and E/2 SW/4 and NW/4 SW/4

All in San Juan County, New Mexico

3. That the wells in the Bisti-Lower Gallup Oil Pool are produced from the Lower Gallup Oil Sand which is found at the approximate depth of 4829 feet in Sunray Mid-Continent Oil Company's Federal "C" Well No. 1 located in the Northwest Quarter of the Northwest Quarter (NW/4 NW/4) of Section 6, Township 25 North, Range 12 West, NMPM, San Juan County, New Mexico.

4. That Sunray Mid-Continent Oil Company, P. O. Box 2039, Tulsa 2, Oklahoma, is the operator of the proposed Central Bisti-Lower Gallup Sand Unit, San Juan County, New Mexico.

WHEREFORE Applicant prays that this application be set for hearing, that notice be given as required by law and that upon the evidence adduced at such hearing, the Commission issue an order establishing the Central Bisti-Lower Gallup Sand Unit and designating Sunray Mid-Continent Oil Company as operator.
