

Gentlemen:

Your Plan of Development for the Henshaw Deep Unit, which was submitted to this office under your letter dated December 19, 1962, provides for the drilling of the Henshaw Deep Unit, Well No. 6, in the ME/4 SE/4 of Section 23, Township 16 South, Range 30 East.

This Well No. 6 was spudded November 25, 1962 and completed January 16, 1963. Therefore, we feel you should amend your 1962 Drilling Program to cover their well and submit another Drilling Program for the calendar year 1963.

We wish to call to your attention, our Certificate of Approval of the Henshaw Deep Unit Agreement, in which we limit our approval to five years after the effective date of the unit unless the acreage is participating, or there is drilling thereon.

Gentlemen:

In compliance with Section 10 of the Henshaw Deep Unit Agreement, Shell Oil Company, as Unit Operator, hereby submits for your approval a Plan of Development for the year 1963.

The plan of development for 1962 reviews the completions of Henshaw Deep Unit Wells 1, 2, and 3A. Henshaw Deep Unit 4, a 9600-foot test located in the SW/4 SW/4 of Section 13-16S-30E, was spudded on December 16, 1961 and completed temporarily abandoned on June 7, 1962 after production tests indicated that the lower Wolfcamp perforated intervals 8953 to 8966 feet and 8743 to 8792 feet were oil bearing but limited reservoirs. Production tests also indicated that the upper Wolfcamp intervals 8413 to 8419 feet and 7830 to 7875 feet were water bearing.

Henshaw Deep Unit 5, the second Devonian test on the unit, was drilled to a total depth of 12,100 feet. This well, located in the NE/4 NE/4 of Section 23-16S-30E, was dry in the Devonian but was completed on August 26, 1962, flowing 305 barrels of oil per day from lower Wolfcamp perforations 8785 to 8801 feet. A third enlargement of the initial participating area for the lower Wolfcamp, which includes Henshaw Deep Unit 5, has been applied for.

The Unit Operator proposes to continue exploitation of the lower Wolfcamp pay on 160-acre density until reservoir conditions indicate closer spacing is advisable. It is planned to initiate drilling operations on Henshaw Deep Unit 6 in the NE/4 SE/4 of Section 23-168-30E by December 31, 1962.

During the year 1963, the Unit Operator proposes to drill one additional lower Wolfcamp test which will be the seventh well on the Henshaw Deep Unit.

This plan of development shall constitute the drilling obligations of the Unit Operator under the terms of the Henshaw Deep Unit for the period ending December 31, 1963. Before this plan expires, another plan for further development of the Unit Area will be submitted.

It is understood that portions of the Plan of Development herein outlined are dependent upon certain information to be gained prior and subsequent to drilling and, therefore, this plan of development may be modified from time to time, with like approval, to meet changing conditions.

Gentlemen:

In compliance with the requirements of Section 11 of the Henshaw Deep Unit Agreement, No. 14-08-001-6453, approved December 3, 1959, Shell Oil Company, as Unit Operator, submits Schedule I, attached hereto, and requests that the land described therein be approved as the acreage which will participate in production from the Henshaw Deep Unit effective August 1, 1962, the first day of the month in which Unit Well No. 5 was completed in the Wolfcamp formation.

The Initial Participating Area, effective December 2, 1960, was approved March 31, 1961, and encompassed the following acreage:

NW/4 and W/2 NE/4 Section 24; SW/4 SE/4 and S/2 SW/4 Section 13; all in T-16-S, R-30-E, N.M.P.M.

The First Enlargement, effective June 1, 1961, was approved February 28, 1962, and increased the Initial Participating Area to 720 acres by the addition of the following acreage to that described above:

SE/4 and E/2 SW/4 Section 24; N/2 NE/4 and NE/4 NW/4 Section 25; all in T-16-S, R-30-E, N.M.P.M.

The Second Enlargement, effective November 1, 1961, was approved February 28, 1962, and increased the Initial Participating area to 800 acres by the addition of the following acreage to that dedicated to the enlarged Initial Participating Area:

NW/4 SW/4 and SW/4 SW/4 Section 24, T-16-S, R-30-E, N.M.P.M.

A Third Enlargement is requested as a result of the successful completion on August 25, 1962, of Henshaw Deep Unit No. 5 in the Lower Wolfcamp reservoir (interval 8785-92 and 8795-8801 feet). Well No. 5 was tested on August 27, 1962, at a daily flowing rate of 305 barrels of oil with a 0.2 per cent BS&W cut through a 16/64-inch choke with a flowing tubing pressure of 800 p.s.i. and a gas-oil ratio of 1650 cubic feet per barrel after a treatment of 450 gallons of acid.

The oil pay zones in all of the wells completed in the Henshaw Deep Unit thus far continue to be relatively thin; however the performance of the wells, with the exception of Henshaw Deep Unit No. 4, indicates excellent lateral communication and only nominal reservoir draw down over sustained producing periods. We are of the opinion that the typical well will drain a large reservoir area (considerably in excess of 160 acres). For example, Henshaw Deep Unit 1 had accumulated 65,423 barrels of oil through July 17, 1962, without a discernible reservoir pressure drop. This indicates a reserve much greater than can be accounted for by volumetric computations using the pay zones apparent in existing wells. We have concluded, therefore, that the acreage contributing to production from this well is several sections in areal extent.

The attached plat reflects the most recent structural interpretation based on seismos and subsurface data from existing wells. You will note that the control afforded by Henshaw Deep Unit 5, NE/4 NE/4 Section 23, and Tenneco U.S.A. Etz No. 1, NW/4 SE/4 Section 26, both in T-16-5, R-30-E, has resulted in a shift of the estimated structural crest approximately one half of a mile to the west of that shown on our original interpretation. On the basis of the improved structural control we believe that the acreage described as S/2 SE/4 Section 14, E/2 Section 23 and NW/4 NW/4 Section 25, T-16-S, R-30-E, can reasonably be assumed to be contributing to production in the Henshaw Deep Unit. This will create an enlarged participating area of 1240 acres described as follows:

S/2 SW/4, SW/4 SE/4 Section 13; S/2 SE/4 Section 14; E/2 Section 23; W/2, W/2 NE/4, SE/4 Section 24; N/2 N/2 Section 25; all in T-16-S, R-30-E, N.M.P.M.

The land described above is unitized and constitutes all the land which can be regarded as being reasonably proved or indicated to be productive of unitized substances in paying quantities.

In support of this application we are submitting the following exhibits:

- 1. A structural map showing the Henshaw Deep Unit, the present enlarged Initial Participating Area and the proposed Third Enlargement of the Initial Participating Area.
- 2. A cross section showing structural and stratigraphic relationships between Henshaw Deep Unit No. 1 and Henshaw Deep Unit No. 5.

3. Schedule I, showing the participating percentage of each lease included or partially included in the enlarged participating area.

The Unit Operator respectfully requests your approval of this application for the Third Enlargement of the Initial Participating Area of the Henshaw Deep Unit to be effective August 1, 1962.
