ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 3 a.m. on February 23, 1966, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 1st day of March, 1966, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Socony Mobil Oil Combany, Inc., seeks permission to institute a waterflood project in the West Henshaw Premier Unit Area, West Henshaw-Grayburg Pool, by the injection of water into the Fremier formation through twenty-six wells in Sections 2, 3, 4, 5, 8, and 10, Township 16 South, Range 30 East, NMPM, Eddy County, New Mexico.
- (3) That the wells in the project area are in an advanced state of depletion and should properly be classified as "stripper"! wells.
- (4) That the proposed waterflood project should result in the recovery of otherwise unrecoverable oil, thereby preventing waste.

(5) That the subject application should be approved and the project should be governed by the provisions of Rules 701, 702, and 703 of the Commission Rules and Regulations.

IT IS THEREFORE ORDERED:

(1) That the applicant, Socony Mobil Oil Company, Inc., is hereby authorized to institute a waterflood project in the West Henshaw Premier Unit Area, West Henshaw-Grayburg Pool, by the injection of water into the Premier formation through the following-described wells in Township 16 South, Range 30 East, NMPM, Eddy County, New Mexico:
