ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on July 12, 1967,  
at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 17th day of July, 1967, the Commission, a  
quorum being present, having considered the testimony, the record,  
and the recommendations of the Examiner, and being fully advised  
in the premises,

FINDS:

(1) That due public notice having been given as required by  
law, the Commission has jurisdiction of this cause and the subject  
matter thereof.

(2) That the applicant, Humble Oil & Refining Company, seeks  
approval of the Paddock (San Angelo) Unit Agreement covering 3758.30  
acres, more or less, of Federal, State, and Fee lands described as  
follows:

LEA COUNTY, NEW MEXICO

TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM

Section 34: SE/4 SE/4

Section 35: E/2 SW/4, SW/4 SE/4, and E/2 SE/4

TOWNSHIP 22 SOUTH, RANGE 37 EAST, NMPM

Section 1: W/2, SW/4 NE/4, W/2 SE/4, and  
SE/4 SE/4

Section 2: All

Section 3: NW/4 NE/4, E/2 NE/4, and S/2

Section 4: SE/4 SE/4

Section 10: All

Section 11: All

Section 12: NW/4, W/2 NE/4, NE/4 NE/4, N/2 SW/4,  
and NW/4 SE/4

(3) That approval of the proposed unit agreement should promote the prevention of waste and the protection of correlative rights within the unit area.

IT IS THEREFORE ORDERED:

(1) That the Paddock (San Angelo) Unit Agreement is hereby approved.

(2) That the plan contained in said unit agreement for the development and operation of the unit area is hereby approved in principle as a proper conservation measure; provided, however, that notwithstanding any of the provisions contained in said unit agreement, this approval shall not be considered as waiving or relinquishing, in any manner, any right, duty, or obligation which is now, or may hereafter be, vested in the Commission to supervise and control operations for the exploration and development of any lands committed to the unit and production of oil or gas therefrom.

(3) That the unit operator shall file with the Commission an executed original or executed counterpart of the unit agreement within 30 days after the effective date thereof; that in the event of subsequent joinder by any party or expansion or contraction of the unit area, the unit operator shall file with the Commission within 30 days thereafter counterparts of the unit agreement reflecting the subscription of those interests having joined or ratified.

(4) That this order shall become effective upon the approval of said unit agreement by the Commissioner of Public Lands for the State of New Mexico and the Director of the United States Geological Survey; that this order shall terminate ipso facto upon the termination of said unit agreement; and that the last unit operator shall notify the Commission immediately in writing of such termination.

(5) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.


