Gentlemen:

Your initial plan of development for the Teas Yates unit area, Lea County, New Mexico, proposing to utilize 10 wells for injection purposes while producing oil from 11 wells within said unit area, has been approved on this date. Of the 10 injector wells, eight are presently producing wells which will be converted to injection status and the remaining two injectors will be established by re-entering two presently plugged wells. The New Mexico Oil Conservation Commission approved the project and the use of these 10 wells for injection purposes by Order No. R-4077, dated December 8, 1970. There are nine wells within the unit area presently producing from the unitized formation which are to remain on producing status. One additional producer will be drilled and the other will be created by reentering a presently plugged well.

One approved copy of the plan is enclosed.
