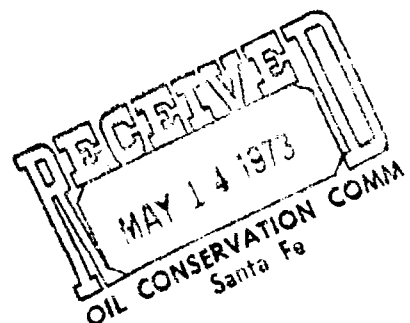

Township 19 South, Range 34 East, N.M.P.M.

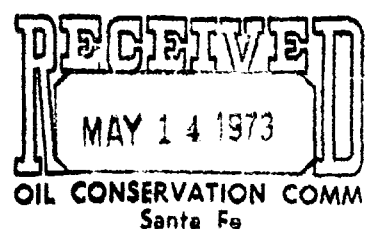

this Application.


WHEREFORE, Applicant prays that after notice and hearing the
