Gentlemen:

Amoco Production Company, as operator of the Old Indian Draw Unit, Eddy County, New Mexico, hereby makes three recommendations concerning expansion of the Delaware Participating Area which are outlined on an attached sheet. Also included is a map which graphically portrays these expansions.

Recommendation No. 1 is based on the completion of Well No. 7 in Lot No. 8 on May 4, 1976 pumping 81 barrels oil and 31 barrels water per day. It is also based on the completion of Well No. 9 in the SE/4 SE/4 of Section 18 on May 16, 1976 pumping 51 barrels oil and 15 parrels water per day. Both wells have performed satisfactorily since their completion.

Recommendation No. 2 is based on the completion of Well No. 10 in Lot 5 on July 21, 1976 pumping 126 barrels oil and 7 barrels water per day. It has also performed satisfactorily since that time.

Recommendation No. 3 is based on the completion of Well No. 12 in Lot 7 on August 10. 1976 pumping 145 barrels oil and 3 barrels water per day. It too has performed satisfactorily since that time.

Well No. 8 was completed May 17, 1976 pumping 30 barrels oil and 95 barrels water per day. It has performed very erratically since that time with periods of nothing but water production. It will be necessary to further watch performance or possibly even repair the well before we can determine its commercial nature.

Well No. 11 was completed August 9, 1976 pumping 27 barrels oil and 46 barrels water per day. In view of the low productivity we most observe further performance on this well also.

By our letter to you of August 10, 1976, File: REO-3205-LF, we advised our tentative plans to drill up to six more Delaware tests this year. Permits to drill these wells have not yet been received and this plus the present scarcity of rigs may push completion of some of these wells into 1977. This in turn will cause us to be undesirably late with our recommended 1977 Plan of Development since such will be completely related to results obtained at these six wells.

We will appreciate your favorable consideration of the foregoing.
