ORDER

This the Star day of May, 1980, in the above entitled and numbered proceeding came on to be heard, this date and time being agreeable to the parties to the proposed agreement hereinafter mentioned, the application of Applicant, Ronald Litle Vick, Guardian of the person and estate of Ferol W. Litle, a person of unsound mind, the personal representative herein, to commit existing mineral lease to a unit agreement, filed herein on the 1st day of May, 1980, and it appearing to the Court that the application is in due and acceptable form; that the Court has venue and jurisdiction of the subject matter and of all persons of whom jurisdiction should be had under the law; and the Court, having heard such application and having heard proof for and against it, and the Court having satisfied itself as to whether or not it is to the best interest of the estate that the proposed agreement to unitize, which is the subject of such application, should be authorized, and finding that it should be authorized and to that end finding that applicant is the Guardian of the person and estate of Ferol W. Litle, a person of unsound mind, herein; that such estate owns an interest in certain property in Union County, New Mexico, which is described as follows:

- (a) A 6.25% royalty interest in and to 520 acres described as SWSW 1/4 of Section 13, SE/4 of Section 14, NE/4 of Section 23, and NW/4 of Section 24, all in Township 23 North, Range 34 East, Union County, New Mexico; and
- (b) An 8.33333% royalty interest in and to 148.36 acres described as Lots 1, 2, 3, and 4, in Section 31, Township 24 North, Range 34 East, Union County, New Mexico;

that a lease for mineral development exists which covers the interest of the estate in such property, which lease is dated June 10, 1975, under which Ferol W. Litle is Lessor and Amoco Production Company is Lessee; that such interest of the estate is subject to such lease; and that a true copy of such lease is attached to such application as Exhibit "A," and is made a part thereof and is also by reference made a part of these findings and of this order; that such lease does not adequately provide for unitization; that it is advisable and advantageous to the estate that the Court authorize the commitment of the royalty interests of the estate in oil, liquid hydrocarbons, gas (including all liquid hydrocarbons in the gaseous phase in the reservoir), gaseous elements, and other minerals, which royalty interests are owned by the estate, to an agreement of the wording shown in Exhibit "B" which is attached to such application and is a true copy of such proposed agreement, which is made a part thereof and is also made a part of these findings and of this order, and which provides for the operation of the areas therein designated as a unit for the exploration, development and production of all such minerals; that the unit to which such proposed agreement relates will be operated in such manner as to protect correlative rights; and that it is to the best interest of the estate to execute such agreement and that the agreement should be executed; that such proposed agreement includes, among other things, provisions:

- (a) That operations incident to the drilling of or production from a well upon any portion of a unit shall be deemed for all purposes to be the conduct of operations upon or production from each separately owned tract in the unit;
- (b) That any lease covering any part of the area committed to a unit shall continue in force in its entirety as long as oil, gas, or other mineral subject to the agreement is produced in paying quantities from any part of the pooled or unitized area, or as long as operations are conducted as provided in the lease on any part of the unitized area; and
- (c) That the royalties provided for on production from any tract or portion thereof within the unit shall be paid only on that portion of the production allocated to the tract in accordance with the agreement;

that the reasons why the proposed agreement concerning such property should be made are as follows:

- (a) It is necessary to establish the unit in order to prevent waste, promote conservation, provide orderly development, and increase the ultimate recovery of the unitized substances;
- (b) To protect the correlative rights of the parties and afford to each of the parties a fair and equitable share of the unitized substances, and it is deemed in the public interest and for the mutual benefit of all the parties that the unit area be developed and operated as though it were a single lease; and
- (c) The Commissioner of Public Lands of the State of New Mexico is authorized to consent to and/or approve such agreement on behalf of the State of New Mexico insofar as it covers and includes lands and mineral interests of the State of New Mexico; and the interest of the Ward is very small, proportionately, and Amoco Production Company may initiate proceedings before the appropriate State agency to force the Ward's acreage into the unit, whereby all funds attributable to the Ward's interest would be held in suspense, unavailable for her support and maintenance;

that the proposed agreement conforms both substantially and literally to the permissible provisions of subsection (a) of Section 369 of the Texas Probate Code and to every permissible and applicable provision of such Section 369; that the ratification of such proposed agreement should be authorized; that as to the bond of Applicant, his general bond is sufficient and that there is no necessity, ground or reason for increased or additional bond;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that such application be and it is hereby approved and that such execution and ratification of agreements entitled "Unit Agreement" and "Unit Operating Agreement Bravo Dome Carbon Dioxide Gas Unit, Union, Harding, and Quay Counties, New Mexico," be, and it is hereby, authorized and ordered.
