has applied to the State of New Mexico, Oil Conservation Division, Santa Fe, New Mexico, for a permit to inject fluid into a formation that is productive of oil or gas. The application proposes to inject fluid in the Queen/Perrose formation in the Querecho Plains Field. The proposed injection wells are located 11 1/2 miles South of Maljamar, New Mexico. Fluid will be injected into strata correlative to subsurface depth interval from 3886 feet to 4222 feet as it exists in the Federal "E" No. 7 well, Section 27, T18S-R32E.
