
Dear Mrs. Jones:

Dugan Production Corp. is the owner of certain mineral rights under the above sections. It is planning to drill a well to the Mancos formation in each section. Under the New Mexico Oil Conservation Division rules, the proration unit for those wells will be 640 acres.

Under the terms of your lease with Bob Bayless, your pooling clause only allows pooling into a proration unit of up to 320 acres for an oil well. Unless you amend your lease with Mr. Bayless to allow for pooling on 640 acres, it will be necessary for Dugan to force-pool your interest. A copy of the applications for force-pooling in each case is enclosed, and this is your legal notice of those applications.
