APPLICATION

Comes now Pogo Producing Company through its attorneys and respectfully requests approval of an unorthodox gas well location, Lea County, New Mexico and in support thereof, states as follows:

1. Applicant is an operator with interests underlying N $\frac{1}{2}$ Section 13, Township 22 South, Range 32 East, N.M.P.M., Bootleg Ridge Morrow Field, Lea County, New Mexico.

2. Applicant wishes to drill an unorthodox gas well to an objective depth in the Morrow formation at approximately 15,500 feet beneath the surface and also to test the Wolfcamp, Strawn, and Atoka Formations underlying said N $\frac{1}{2}$ Section 13. Said well is to be drilled at a location 1,980 feet from the North line and 990 feet from the East line of said Section 13.

3. Applicant proposes to dedicate said N $\frac{1}{2}$ Section 13 to said well.

4. A well at said unorthodox location will better enable the Applicant to produce gas underlying the proration unit.


5. Approval of the unorthodox location will be in the interests of conservation, prevention of waste and protection of correlative rights.

WHEREFORE, Applicant respectfully requests that this case be set for an examiner's hearing on the November 18, 1987 docket, or on the docket following on a date as close as possible to November 18, 1987.
