

Re: Case Nos. 10869 and 10881 Being Reopened to Permit Operators in the South Dagger Draw-Upper Pennsylvanian Associated Pool in Eddy County, New Mexico to Appear and Present Evidence Regarding the Continuation or Adjustment of the 7,000 to 1 Gas/Oil Ratio Limitation Established by the Division for this Pool

Dear Mr. LeMay:

Yates Petroleum Corporation appeared and presented testimony at the December 2, 1993 Examiner hearing in the above-referenced cases which resulted in special rules and regulations being adopted for the South Dagger Draw-Upper Pennsylvanian Associated Pool providing for a limiting gas/oil ratio of 7,000:1 cubic feet of gas per barrel of oil. Pursuant to Order No. R-10050 which was entered in these cases, the cases have been reopened and are included on the September 21, 1995 Examiner hearing docket to provide operators in the pool an opportunity to appear and present testimony regarding the continuance or adjustment of the limiting gas/oil ratio for this pool of 7,000:1.

Yates Petroleum Corporation is a major operator in the South Dagger Draw-Upper Pennsylvanian Associated Pool. Based on our operations in this pool under a 7,000:1 gas/oil ratio, it is our experience that adoption of this gas/oil ratio on a permanent basis will not adversely affect this reservoir by reducing the ultimate recovery of oil and gas therefrom and that a permanent gas/oil ratio of 7,000:1 will enable operators in this pool to produce the oil and gas therefrom in a manner that will protect the correlative rights of all interest owners in this pool.

Yates Petroleum Corporation supports the adoption of a 7,000:1 gas/oil ratio for the South Dagger Draw-Upper Pennsylvania Associated Pool on a permanent basis.

Marathon Oil Company supports a continuation of the current gas-oil limitation for the South Dagger Draw Upper Pennsylvanian Associated Pool of 7,000 cubic feet of gas per barrel of oil. We believe maintaining the current GOR limitation will provide the opportunity for operators to develop reserves within the pool without unnecessarily restricting gas production.



On behalf of Conoco Inc. (the original applicant in Case 10881), and with the concurrence of Yates Petroleum Corporation (the original applicant in Case 10869), I am requesting that the referenced Reopening of these cases now set for June 29, 1995 be continued to the Division Examiner hearing now scheduled for September 21, 1995.

Neither Conoco nor Yates has had sufficient time to evaluate the additional data developed in this last year and to contact the other operators in the pool to determine what if any change should be made from the current 7000-1 GOR.
