Hello Ms. Mitchell,

I believe we are on the same page after our phone conversation last week, and I am sending this email merely as a follow up.

The fluid level test requirement in paragraph 11 of Order R-21061 needs to be conducted during the pilot project following an injection test with a relatively high flow rate, pressure, and volume. The intent is to determine if the fluid level in wells without packers can rise following injection into the reservoir. An adequate test of this during the pilot project may lessen concerns leading to being overly conservative when drafting potential rules governing these projects to be adopted in the future.

Additionally, the OCD is in agreement the requirements in the last sentence of paragraph 11, "At least ten (10) business days prior to conducting the test, EOG shall submit the proposed test conditions and protocol for OCD's approval" only applies if EOG proposes test conditions which do not conform with what is provided in the rest of paragraph 11.
