Gentlemen:

The initial Bone Spring Formation Participating Area "I" is hereby approved effective as of November 30, 2011, pursuant to Section 11 of the Poker Lake Unit Agreement, Eddy County, New Mexico. This participating area has been designated NMNM71016Q.

The application establishes an initial Bone Spring Formation Participating Area "I" of 160.50 acres and is based upon the completion of unit well CVX JV BS 7H, located in the SW¹/₄SE¹/₄ (SHL) and in the NW¹/₄NE¹/₄ (BHL) of Section 2, T.25S., R.30E., unit tract No. 66, state lease, with an initial potential of 499 BOPD and 1,183 MCFPD on November 30, 2011, from the Bone Spring Formation.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" are returned herewith. Please advise all interested parties of the approval of the initial Bone Spring Formation Participating Area "I" effective as of November 30, 2011.

Any production royalties that are due must be reported and paid within 30 days of the Bureau of Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (30 CFR 218.54). 
