ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on September 28, 2006, at Santa Fe, New Mexico before Examiner David R. Catanach.

NOW, on this 10th day of October, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Sandoval County, New Mexico for the production of oil from the Mancos formation, bearing the designation of Eagle Springs-Mancos Oil Pool (Pool Code 97029). The Eagle Springs-Mancos Oil Pool was discovered by the Penwell Energy Company Eagle Springs 8 Federal Well No. 2M (API No. 30-043-20950) located in Unit B of Section 8, Township 19 North, Range 4 West, NMPM, which was completed in the Mancos formation on March 23, 2001. The top of the perforations is at 3,206 feet.

(3) There is need for the creation of a new pool in Rio Arriba County, New Mexico for the production of gas from the Mesaverde formation, bearing the designation of Laguna Colorado-Mesaverde Pool (Pool Code 97072). The Laguna Colorado-Mesaverde Pool was discovered by the Schmidt Production Company Laguna Colorado 2

Well No. 6 (**API No. 30-039-24199**) located in Unit F of Section 2, Township 23 North, Range 1 West, NMPM, which was completed in the Mesaverde formation on December 16, 2000. The top of the perforations is at 4,685 feet.

(4) There is need for the creation of a new pool in San Juan County, New Mexico for the production of gas from the Pictured Cliffs formation, bearing the designation of Witty Springs-Pictured Cliffs Pool (**Pool Code 96872**). The Witty Springs-Pictured Cliffs Pool was discovered by the Dugan Production Company Wit's End Well No. 6 (**API No. 30-045-31010**) located in Unit P of Section 2, Township 23 North, Range 10 West, NMPM, which was completed in the Pictured Cliffs formation on June 11, 2002. The top of the perforations is at 1,142 feet.

(5) There is need for the abolishment of the Conner-Fruitland Sand Pool (**Pool Code 75030**) in San Juan County, New Mexico in order to correct pool nomenclature. The abolished acreage will be placed in the Harper Hill-Fruitland Sand-Pictured Cliffs Pool (**Pool Code 78160**).

(6) There is need for extensions to the Aztec-Pictured Cliffs Pool, the Bisti-Chacra Pool, the Bisti-Lower Gallup Oil Pool, the Fulcher Kutz-Pictured Cliffs Pool, the South Gallegos-Fruitland Sand-Pictured Cliffs Pool, the Gallegos-Gallup Associated Pool, the Harper Hill-Fruitland Sand-Pictured Cliffs Pool, the Horseshoe-Gallup Oil Pool, the West Kutz-Pictured Cliffs Pool, the South Los Pinos-Fruitland Sand-Pictured Cliffs Pool, the Pinon-Fruitland Sand Pool, the North Pinon-Fruitland Sand Pool, the Twin Mounds-Fruitland Sand-Pictured Cliffs Pool, the Ute Dome-Dakota Pool, the WAW-Fruitland Sand-Pictured Cliffs Pool and the White Wash-Mancos-Dakota Oil Pool, all in San Juan County, New Mexico; the Blanco-Mesaverde Pool, the East Blanco-Pictured Cliffs Pool, the South Blanco-Pictured Cliffs Pool, the South Blanco-Tocito Oil Pool, the Burro Canyon-Tertiary Pool, the Cabresto Canyon-Tertiary Pool, the Gallo Canyon-Gallup-Dakota Oil Pool, the Gavilan-Chacra Pool, the Gavilan-Mancos Oil Pool, the La Jara-Pictured Cliffs Pool, the La Jara Canyon-Tertiary Pool, and the Otero-Chacra Pool, all in Rio Arriba County, New Mexico; the Blanco-Pictured Cliffs Pool and the Rosa-Pictured Cliffs Pool, both in Rio Arriba and San Juan Counties; the Chaco Wash-Mesaverde Oil Pool and the Hospah-Dakota Oil Pool, both in McKinley County; and the Rusty-Chacra Pool in San Juan and Sandoval Counties, New Mexico.

(7) The effective date of this order and all creations, abolishments and extensions included herein should be October 1, 2006.

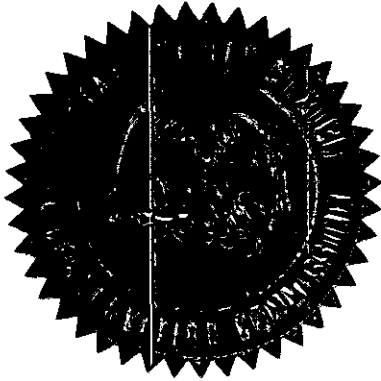

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard

unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable. '

(2) The effective date of this order and all creations, abolishments and extensions included herein shall be October 1, 2006.
