Reference is made to your application received on January 21, 2016.

You have requested to drill this horizontal well at an unorthodox gas well location described above in the referenced pool or formation. Spacing in this pool is governed by the Special Rules and Regulations for the Basin Fruitland Coal (Gas) Pool, as amended by Order No. R-8768-F, effective July 17, 2003, which provide generally for 320-acre units with wells to be located at least 660 feet from any unit boundary. This location is unorthodox because portions of the proposed completed interval are less than 660 feet from an outer boundary of the project area.

Your application has been duly filed under the provisions of Division Rules 19.15.15.13 NMAC and 19.15.4.12.A(2) NMAC.

It is our understanding that you are seeking this location because the entry point was the best location for penetration into the project area.
